This request form must be submitted to the appropriate Division Traffic Engineer(s) where the event or activity will be held at least ninety (90) days prior to the scheduled beginning of the event. **We will not issue a permit unless you have a letter of approval from NCDOT.** Special events include one-time, annual, or periodic bicycle races, marathons, or other foot races, festivals, charity walks, parades, or other events outside the normal usage of the State Highway System. This application must be filed not less than seventy-two (72) hours in advance of the event unless for a high school parade or similar function, a special permit may be issued with twenty four (24) hours' notice. Prior to obtaining a permit for the activity listed above, all applicants are directed to read and acknowledge their understanding of Chapter 16 under the Town of Mooresville Code of Ordinances.
